Scheduling

Cancellation Policies

If you need to cancel or reschedule, please provide at least 24-hour notice. You can do this via email or phone (866)994-7539. Because I run a full-time practice, no-shows or cancellations with less than 24-hour notice are charged in full.

Workshops/Retreats/Courses/Events (hereafter designated simply as “event”):

Payment

Since some events fill quickly due to limited space, it is advisable to sign up as early as possible. In order to reserve a space in any event, we require full payment, or the deposit arranged ahead of time.

To help insure fulfillment of the mission and to lower costs, we ask all who are capable of doing so to please pay the full amount of their event at the time they sign-up, rather than making a deposit. Deposit arranged can only be made on an individual basis and must be approved at the initial date of sign-up.

Balance of payment is due fourteen (14) days before event. Deposits are payable in U.S. currency only. Overseas residents must pay by checks drawn on U.S. banks or use a credit card.

Cancellation Policies

Cancellations must be made by phone (866)-994-7539.

Cancellations must occur within seven full days of event.

If you cancel registration for an event at least seven full days before the start, the amount paid toward the event, minus a \$75-per-event, per-person processing fee, will be returned to you. If you cancel an event with less than seven days notice, you forfeit 20% of the paid event price. The balance will be returned to you.
